Non-Profit of the Year: Recognizes a nonprofit organization that demonstrates meaningful community impact, responsible stewardship, collaborative leadership, and outstanding service in the Loveland-Johnstown area.

Heart Award: Recognizes an individual, business, or organization that exemplifies compassion, generosity, community spirit, and extraordinary service to others in the Loveland-Johnstown area.
